- Military personnel including Reservists and National Guard with I.D. This includes retired Military with “retired” credentials. **(Military picture ID front & back)**  
-DD214/Discharge papers do not qualify — if you cannot submit your ID please locate a dealer in your area.
- Corrections Officers, including Parole and Probation Officers **(LE Department Picture ID front & back)**

In addition to approved purchaser I.D., applicants must submit completed form with original product UPC(s), copy of dated cash register receipt and/or dated itemized sales invoice. Offer may not be combined with any other SCCY Industries offer. Please allow 4 to 6 weeks from submission receipt for delivery of Visa prepaid card.

Multiple rebates per household are allowed. Limit of one rebate per Serial # of a qualifying SCCY Industries product purchased. In order to receive your SCCY Industries Visa® Prepaid Card you must purchase a qualifying SCCY Industries product.
